

RESOLUTION 102-2021

WHEREAS, pursuant to C.R.S. 39-5-128, special districts within Washington County must certify to the Board of County Commissioners the levy of said special districts for the ensuing fiscal year (2021); and

WHEREAS, the Board of County Commissioners has received said certifications from the hereinafter described special districts; and

WHEREAS, pursuant to C.R.S. 39-1-111, the Board of County Commissioners must levy taxes for special districts as provided by law no later than December 21st, 2021, and;

WHEREAS, the Board of County Commissioners is desirous of levying said taxes at this time.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Washington County that there shall be and there is hereby levied against all taxable property, real, personal and mixed, tangible and intangible, not exempt by law within the corporate limits of each of the following special districts, the following taxes, to wit:

BE IT FURTHER RESOLVED that the Board of County Commissioners of Washington County in certifying the mill levies of the aforementioned special districts is performing a ministerial and non-discretionary act to comply with the requirements of Sections 39-1-111 and 39-5-128, C.R.S.; that the Board of County Commissioners has no authority to modify the mill levies so certified to it; that the Board of County Commissioners has presumed that the aforementioned special districts have complied with the Colorado constitutional and statutory requirements concerning said levies; and

therefore, that the Board of County Commissioners assumes no liability or responsibility associated with any levy of any of the above-noted special districts except for the ministerial, non-discretionary act of certification.
