## RESOLUTION 65-2020

## RESOLUTION RESTRICTING PUBLIC ACCESS TO COUNTY BUILDINGS

WHEREAS, C.R.S. § 30-10-109 authorizes the Washington County Board of County Commissioners to prescribe the days and hours that County offices will be open for the transaction of business; and

WHEREAS, by prior action on January 14, 2020 the Board of County Commissioners adopted Resolution 07-2020; and

WHEREAS, the BOCC has declared a local emergency pursuant to C.R.S.§ 24-33.5-709 by ratification of Resolution 62-2020 on March 24, 2020, and finds that in order to protect the health of its employees and the public health, it will restrict public access to certain County buildings, as set forth herein.

NOW, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY, COLORADO:
