

RESOLUTION 90-2020

WHEREAS, pursuant to C.R.S. 30-11-101(1) (d), the Board has the authority to do all acts in relation to property necessary to exercise the corporate and administrative powers of the County; and

WHEREAS, pursuant to C.R.S. 30-11-107 (e) the Board has the authority to manage the concerns of the county; and

WHEREAS, pursuant to C.R.S. 30-11-101 (1) (i) the Board has the authority to dispose of county property by sale of said property if the Board determines it is in the best interests of the County; and

WHEREAS, based upon the aforementioned, the Board has learned that the Washington County Sheriff has determined to dispose of five Glock model 31, and five Glock model 32 pistols from the Washington County Justice Center Transport Department as surplus, since the weapons have been replaced over the last two years with .9mm caliber Glock pistols.

Having reviewed this matter at a regularly scheduled Board meeting held on December 8th, 2020 the Board of County Commissioners determined to take the following action:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON COUNTY as follows:

1. The Board hereby recognizes the sale of ten Glock pistols as reported by the Washington County Sheriff for the total amount received of \$3,900.00 to wit:

- e.) Serial # FPX253 Glock Model 31 .357 caliber Gen 3
- f.) Serial # FPX925 Glock Model 32 .357 caliber Gen 3
- g.) Serial # GHZ413 Glock Model 32 .357 caliber Gen 3
- h.) Serial # GHZ432 Glock Model 32 .357 caliber Gen 3
- i.) Serial # GHZ433 Glock Model 32 .357 caliber Gen 3
- j.) Serial # GHZ434 Glock Model 32 .357 caliber Gen 3

Guns were sold to staff at a cost of \$390.00 each. Background checks and transfer paperwork was done by a local gun dealer. The amount of \$3,900.00 will be deposited with the Washington County Treasurer and placed in the Justice Center fund.
