It was moved by Commissioner Ward and duly seconded by Commissioner Ramey to approve Building Permit BP25-22 for David and Julie Foy at 40588 County Road KK.5, to add on a wood frame extension for a handicap porch. On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ramey and duly seconded by Commissioner Ward to approve Building Permit BP25-28 for Stephanie O'Neil at 1225 North Main Avenue, Akron, Colorado, for an additional 700 square feet at her primary residence with Glosson Construction doing the work. On roll call vote, all votes being yes, the motion carried.

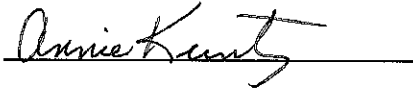
It was moved by Commissioner Ward and duly seconded by Commissioner Ramey to approve Capital Purchase for the Ambulance to Handtevy for the app for medication management they have for \$4,779.00. On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ramey and duly seconded by Commissioner Ward to **approve the Capital Purchase for the Ambulance Service in the amount of \$4,318.20 to Stryker for the purchase of power cords and adapter kits for their cardiac monitors.** On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ward and duly seconded by Commissioner Ramey to **approve the Capital Purchase for the County Clerk and Recorder for a 4-ton Mitsubishi 5-head mini split to update the AC and heating in the Clerk and Election Offices.** On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ramey and duly seconded by Commissioner Ward to **adopt Resolution 33-2025, a resolution imposing a temporary moratorium on Washington County's processing of applications for wind energy conversion systems in all unincorporated portions of Washington County pending consideration of systems regulations, this moratorium in place until November 25, 2025.** On roll call vote, all votes being yes, the motion carried.
