The Regular meeting was called to order by Chairman Jefferson at 9:01 am.

It was moved by Commissioner Ramey and duly seconded by Commissioner Ward to approve the **consent agenda as amended**. On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ramey and duly seconded by Commissioner Ward to **authorize the Chairperson to sign the Washington County Event Center Commissary Agreement with Kevin Brown, Mustache Enterprises**. On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ward and duly seconded by Commissioner Ramey to **authorize the Chairperson to sign the Commissary Agreement between Washington County and Filla Honey Farm, Jessica Filla for this year**. On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ramey and duly seconded by Commissioner Ward to **approve Agreement for Services and authorize the Chairperson to sign the agreement between Washington County Commissioners and Department of Human Services with Nancy Origer who is an independent contractor to clean the DHS buildings**. On roll call vote, all votes being yes, the motion carried.

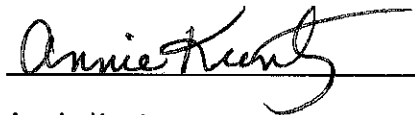
It was moved by Commissioner Ward and duly seconded by Commissioner Ramey to **accept the Capital Purchase for Road and Bridge District One and Two for a jumping jack for a total of \$4,000 to be shared \$2,000 for each district.** On roll call vote, all votes being yes, the motion carried.

It was moved by Commissioner Ramey to **approve Wild Side Contract for the 2025 Washington County Fair Rodeo.** Motion died for lack of a second.

It was moved by Commissioner Ward and duly seconded by Commissioner Jefferson to **accept the Contract with the CERVI Championship Rodeo Company in Greeley Colorado in the amount of \$52,000 for two performances.** On roll call vote, Commissioner Jefferson and Commissioner Ward voting yes, and Commissioner Ramey voting no, the motion carried.

It was moved by Commissioner Ward and duly seconded by Commissioner Ramey to **adopt Resolution 22-2025 allowing for the Nursing Home to sell three electric dryers to employees for \$75 each.** On roll call vote, all votes being yes, the motion carried.
