## Resolution 73-2018

Whereas, Carl Lindahl (EX18-08) requested a subdivision exemption approval to divide a 320 acre parcel to create a 20 acre parcel located in the NE1/4NW1/4 of Section 20, Township 4 North, Range 51 West, and

Whereas, the newly created 20.00 acre parcel contains a well, septic, the existing residence, two grain bins and nine buildings; and

Whereas, said exemption was recommended favorably by the Planning Commission as submitted with no additional stipulations and conditions.
