As a candidate, you are also encouraged to become familiar with the requirements of Article XXVIII of the Colorado Constitution (Campaign and Political Finance); Article XIV of the Colorado Constitution (Counties); Title 1 Article 45, C.R.S. (Fair Campaign Practices); Title 1 Article 4, C.R.S. (Elections - Access to Ballot by Candidates); Title 30 Article 10 Sections (County Officers); and the Colorado Secretary of State Campaign Finance Rules.

Definition of a Candidate

COLORADO CONSTITUTION ARTICLE XXVIII (Amendment 27)

Section 2 (2) “Candidate” means any person who seeks nomination or election to any state or local public office to be voted on in this state at any primary election, general election, school district election, special district election, or municipal election. “Candidate” also includes a judge or justice of any court of record who seeks to be retained in office under the provisions of section 25, article VI. A person is a candidate for election if they have publicly announced an intention to seek election to public office or to retain a judicial office and have subsequently received a contribution or made an expenditure in support of the candidacy. A person remains a candidate for this article as long as they maintain a registered candidate committee. A person who maintains a candidate committee after an election cycle but has not publicly announced an intention to seek office in the next or any subsequent election cycle is still considered a candidate for the purposes of this article.

Steps for County Candidacy

The following steps outline how to become a candidate for elected office in Washington County, including Assessor, Clerk and Recorder, Commissioner, Coroner, Sheriff, Surveyor, and Treasurer. For details on ballot access filings, forms, and other county-specific information, contact the Washington County Clerk and Recorder's Office or your respective [County Clerk](#).

Step 1: Meet Candidate Qualifications

Review the candidate qualifications outlined in the Colorado Constitution and Colorado Revised Statutes (C.R.S.) on pages 4-5 to ensure you meet all requirements for the office you seek.

Step 2: Understand Campaign Finance Laws

Understand and comply with the [Colorado Campaign and Political Finance Rules](#), the Colorado Constitution Article XXVIII (Amendment 27), and [Colorado Revised Statutes](#). Also refer to the Campaign and Political Finance section of the Secretary of State website.

Step 3: Announce Your Intent to Run for Office

Be aware of and follow state law regarding public announcements. Refer to the Secretary of State website for more information. Step 3: [Register a Candidate Committee](#). Register a Candidate Committee with the Secretary of State before receiving or spending any money. If you only spend personal funds and do not accept contributions, [you may qualify as a standalone candidate](#).

Step 4: File a Candidate Affidavit

Your Candidate Affidavit will need to be filed with the Secretary of State within 10 days of becoming a candidate. This form is available in [TRACER](#) and must be filed electronically. The affidavit is an attestation that the candidate has familiarized themselves with campaign finance laws and regulations. Be sure to read the laws before submitting the affidavit.

Step 5: Get Your Name on the Ballot

Will you collect signatures on a petition? Go through your party's assembly process for choosing candidates? Both? Choose which approach(es) you will take to place your name on the ballot and follow the directions carefully.

Qualifications for County Offices

The table below provides a general overview of candidate qualifications for County elected offices and should be used for reference only. Please review the Colorado Constitution and Colorado Revised statutes for current applicable laws. Please note that no person is eligible to be a candidate for more than one office at a time, except for special district boards.

Access to the Ballot

In Colorado, the process of getting on the ballot depends on a candidate's political party affiliation. Major party candidates must either obtain their party's designation through the assembly process or collect enough valid signatures on a petition. Minor party candidates typically gain ballot access through their party's assembly and do not participate in primary elections. However, if multiple minor party candidates qualify for the same office through petition or assembly, they must run in a primary election before advancing to the general election [C.R.S. § 1-4-1304(1.5)(c)- (d)]. Unaffiliated candidates must qualify through the petition process and, if successful, are placed directly on the general election ballot without a primary election.

All candidates for any primary election shall be placed on the ballot either by certificate of designation by the assembly or by petition [C.R.S. § 1-4-102].

Certificate of Designation by Party Assembly

Assemblies of both the major and minor political parties may designate candidates for nomination to the primary election ballot. Candidates interested in this process should contact their political party (see page 16) for assembly protocols, dates, and rules. These assemblies shall be held no later than 73 days before the primary election. For 2026, this date is Tuesday, March 24, 2026.

If you receive your party's nomination, your party must file a certificate of designation by assembly. In addition, you must submit a signed written acceptance of the nomination—unless your party includes it in their submission—to the Washington Election Division no later than four days after the assembly ends [C.R.S. § 1-4-601(1), 1-4-601(2)(a), 1-4-601(3)(a), 1-4-604(3), 1-4-1304(1.5)(b)(I), 1-4-1304(3), 1-4-1304(4)].

- Your acceptance must state your name as you want it to appear on the ballot.
- One nickname may be included if it is regularly used and does not contain any part of a political party name.

Major Political Party Candidates

- To qualify through an assembly, candidates must have been affiliated with the party since at least the first business day of January immediately preceding the primary election, unless party rules state otherwise [C.R.S. § 1-4-601(4)(a)].
- If no candidate receives 30% or more of the votes, a second ballot shall be cast. If no one reaches 30% on the second ballot, the two candidates with the highest number of votes are certified [C.R.S. § 1-4-601(2)(a)].

Minor Political Party Candidates

- A candidate cannot be nominated if they were registered with a major party at any time after the first business day of January before the general election, unless allowed by the minor party's rules [C.R.S. § 1-4-1304(2)(c)].
- Each candidate receiving 30% or more of the votes at the minor party assembly shall be designated by the assembly to the ballot [C.R.S. § 1-4-1304(1.5)(b)(II)]

Certificate of Designation by Petition

The petition process involves circulating a written petition to other eligible voters and collecting their signatures in support of your candidacy. Unaffiliated candidates must be nominated by petition. Affiliated candidates may be nominated by petition, in addition to or as an alternative to the assembly process. The County Clerk must approve a petition form before circulation.

Contact the Washington Elections Division at (970) 345-6565 or email akuntz@co.washington.co.us to request the template needed for petition approval. The office will approve or reject a petition form no later than the second business day after submission [C.R.S. § 1-4-903].

- Major and Minor Party Candidates for county office must be affiliated with the party since at least the first business day of January immediately preceding the election in which they are circulating petitions.
- Unaffiliated Candidates for county office must be registered as unaffiliated no later than this same date [C.R.S. § 1-4-801(3), 1-4-802(1)(g)(II)]. If a major party candidate chooses to seek nomination through both petition and assembly, they cannot petition onto the ballot if they receive less than 10% of the vote at their party assembly for the same office [C.R.S. § 1-4-801(4)].

For additional petition requirements, visit the [Colorado Secretary of State's website](#). If you are running for a municipal office, contact your local municipal or town clerk in the city or town where you reside.

Requirements for Petition Signers and Signatures

Only eligible voters registered within Washington County may sign the petition for countywide elected offices.

Voters cannot sign multiple petitions for different candidates seeking the same office [C.R.S. § 1-4- 904(2)(a)-(b)].

Major Party

- Only eligible voters from the political subdivision may sign the petition.
- Signers must be affiliated with the political party named in the petition for at least 29 days before signing.
- The petition signatures must be at least 10% of the votes cast in the previous primary election for that office. (If there was no primary, 10% of the votes cast in the most recent general election with a candidate for that office.)

Minor Party

- Only eligible electors from the political subdivision are permitted to sign the petition.
- There are no requirements for parties.
- The candidate needs either less than 750 votes or 2% of the total votes cast for all candidates for that office in the most recent General Election, whichever is less.

Unaffiliated

- Only eligible electors in the district or political subdivision
- Signers may be affiliated with a party or unaffiliated
- The candidate needs the lesser of 1000 or 2% of the votes cast for all candidates in the most recent *General Election (whichever is less)
- Unaffiliated petitions may be amended once, no later than 3 p.m., 85 days before the General Election

Petition Circulation and Filing Dates

Completed petitions must be filed with the Washington Elections Division by the statutory deadline. The Elections Division will verify the signatures and notify the candidate of sufficiency or insufficiency of the petition [C.R.S. § 1-4-907].

Unaffiliated Candidates [C.R.S. § 1-4-802(1)(d)(I), 1-4-802(1)(f)(I)]	173 days before the general election: Thu. May 14, 2026	5 p.m. on the 117 th day before the general election: Thu. July 9, 2026

Additional Information

- Circulators must complete an affidavit attached to each petition section, which must be signed and notarized after collecting signatures but before submitting the petition for review [C.R.S. § 1-4-905 (1)-(2)].
- Candidates must submit a list of all petition circulators, including their names, addresses, and the petition section numbers they circulated. This list must be filed with the Washington Elections Division along with the completed petitions [C.R.S. § 1-4-905(5)].
- Review statutory rules and contact the Colorado Secretary of State for information on identification requirements for paid and volunteer circulators, as well as any required training.

Certificate of Designation by Write-In

A write-in candidate is someone whose name isn't on the ballot, but voters can still vote for them by writing in their name.

Any person who wishes to be a write-in candidate must file an Affidavit of Intent stating which office they desire and that they are qualified to assume those duties if elected. The Affidavit of Intent is available online. It must be filed with the County Clerk and Recorder by the close of business on the 67th day before a primary election or by the close of business on the 110th day before any other election. CRS 1-4-1101 and 1102.

Filing Deadlines

- Primary Elections: Close of business the 67th day before the election – Fri. April 24, 2026
[C.R.S. § 1-4-1102(1)]
- General Elections: Close of business the 110th day before the election – Thu. July 16, 2026
[C.R.S. § 1-4-1102(1)]

Ballot Order

The Washington Elections Division determines the order of county candidate names on the primary and general election ballots in accordance with statutory procedures.

Primary Election

- Candidates designated by the assembly are listed first, in order of the number of votes received at the assembly.
- If two or more candidates receive the same number of votes at the assembly, the order is determined by lot draw conducted by the Washington Elections Division.
- Candidates qualified by petition are listed next, with their order determined by a lot draw conducted by the Washington Elections Division.

[C.R.S. § 1-4-103]

General Election

- Major party candidates are listed first in an order determined by lot draw conducted by Washington Elections Division.
- Minor party candidates are listed next. If more than one minor party has a candidate for the same county office, their order is determined by lot.
- Unaffiliated candidates are listed last.

[C.R.S. § 1-5-404]

On the Ballot

All candidates who will be listed on the ballot for an election will have additional responsibilities and opportunities, including but not limited to:

You must:

- Provide a verbal pronunciation of your name for inclusion in the audio ballot. Instructions will be sent by email. You may:
- Attend equipment testing approximately one month before Election Day. Contact the Washington elections office to notify them of your interest and receive details.
- Appoint watchers to represent you during the election.
- If you win your primary, attend the lot draw in late August to determine ballot order. Contact the chair of your political party to express your interest and receive details.

Running for Municipal Office

If you are thinking about running for municipal office, you should contact the city or town clerk's office where you live. You will submit any assembly documents, petitions, or write-in affidavits through their office.

Running for School Board Office

If you're thinking about running for the School Board, contact the school district and ask for their designated election official. You will submit any assembly documents, petitions, or write-in affidavits through their office. This office will then coordinate with Washington County to have your name on the ballot.

Running for Special District Office

If you are thinking about running for a Special District Board, contact the special district and ask for their designated election official. You will submit any assembly documents, petitions, or write-in affidavits through their office. This entity may conduct its own election or coordinate with Washington County to get your name on the ballot. Candidate Affidavit & Campaign Finance Filings

After officially becoming a candidate, you are required to file a Candidate Affidavit with the Secretary of State within 10 days. Campaign finance filings are completed online with the Secretary of State. Visit their website to learn more about [Candidate Affidavit instructions](#).

Timeline for Filing Campaign Finance Filings

A calendar for campaign finance filings is available on the Secretary of State website under "Campaign Finance." Filing deadlines follow the schedule outlined in C.R.S. § 1-45-108(2). The Secretary of State imposes penalties for late filings. For imposed penalties, refer to the Secretary of State Campaign and Political Finance Rule 18 [Colo. Const. art. XXVIII, § 10; C.R.S. § 1-45-111.5].

Frequently Asked Questions

Can I file my paperwork at the County Clerk and Recorder's Office?

Some forms must be filed with the Washington Elections Division, while others must be filed with the Colorado Secretary of State. **Linked forms here are provided as informational samples only.** Please contact the listed entity for the current, official forms to file.

Municipal office candidates should file with the Municipal or Town Clerk in the city or town where they reside. All other candidates should contact the Secretary of State's office to confirm where to file their paperwork.

Is there a deadline for filing campaign finance paperwork?

Yes. Filing deadlines are outlined in the [Campaign and Political Finance Calendar](#) available on the Secretary of State's website.

When do I need to file my ballot access paperwork with the county clerk?

Refer to Colorado Revised Statutes Title 1, Article 4, specifically:

- C.R.S. § 1-4-604(3)
- C.R.S. § 1-4-601(3)(a)
- C.R.S. § 1-4-801(5)
- C.R.S. § 1-4-802(1)(f)(I-II)
- C.R.S. § 1-4-1304(3-4)
- C.R.S. § 1-4-1102(1-2)

Can I withdraw my candidacy after declaring?

If you wish to withdraw your candidacy, the correct procedure depends on your status on the ballot.

- If you have already been designated or nominated to the ballot by party assembly or by petition and wish to withdraw your candidacy, you may submit a signed and notarized **Statement of Withdrawal Form** to the Washington County Clerk and Recorder. If the form is not filed in time for your name to be taken off the ballot, the election will proceed, and any votes cast for you will be deemed invalid and will not be counted. The Statement of Withdrawal Form is available online at www.sos.state.co.us.
- If you are a candidate but have not yet been designated or nominated to the ballot and wish to withdraw your candidacy, you may submit a signed letter of withdrawal to the Washington County Clerk and Recorder. If you are running for a municipal, school board, or special district office, please submit your withdrawal to the designated election official in that jurisdiction.

Where do I submit my candidate paperwork for County office?

The following forms must be filed at the Washington County Clerk and Recorder's Office election room:

- Certificate of Designation by Party Assembly (provided by the political party at the assembly)
- Candidate Acceptance of Nomination by Designation (provided by the political party at the assembly)
- Major Party, Minor Party, or Unaffiliated Designation Petition forms (provided by the county)
- Candidate Acceptance of Nomination by Petition (Provided by the County)
- Affidavit of Intent for Write-In (supplied by the county)

File the following form electronically with the Colorado Secretary of State:

- Candidate Affidavit
- Campaign Finance Forms
- Committee Registration

Where do I file my petition and certificate of designation for the County office?

Please refer to the current year's Election Calendar on the Secretary of State's website for important dates related to your candidacy. Visit www.coloradosos.gov and click on 'Elections & Voting' then 'Election Information'.

When do I file my campaign finance paperwork?

Please check the filing calendar at www.coloradosos.gov. Click on 'Elections & Voting,' then Campaign Finance.

How do I verify my voter registration and party affiliation?

Check your voter registration record at the [Secretary of State's website](http://www.coloradosos.gov). The Washington Elections Division can also verify your registration status, affiliation, and date of affiliation.

Who do I contact for candidate qualifications, ballot access, or election requirements?

How can I get a list of voters in the county/municipality/district for which I am a candidate?

How can I find out who the other candidates are?
