TO THE ELECTORS OF WASHINGTON COUNTY:

NOTICE IS HEREBY GIVEN that Tuesday the 25TH day of June a Primary Election and Special Congressional Vacancy Election will be held in Washington County as an allmail ballot delivery election.

Ballots were mailed to each active registered elector the week of June 3rd-June 7th, 2024 in accordance with C.R.S. Section 1-5-205(1)(a-d).

<u>DEMOCRATIC AND REPUBLICAN VOTERS:</u> Your ballot packet will contain the primary election candidates and the CD4 Congressional Vacancy candidates.

<u>Unaffiliated Voters:</u> Your mail ballot packet contains both Democratic and Republican ballots with the primary election candidates and the CD4 Congressional Vacancy candidates, mark and return <u>ONLY ONE</u> ballot and destroy the other. <u>If you mark and return both ballots, neither will count.</u>

MINOR PARTY VOTERS: Your ballot packet will contain a ballot that only contains the CD4 Congressional Vacancy candidates ONLY.

<u>SELF-AFFIRMATION:</u> The self-affirmation on the Mail Ballot Envelope <u>MUST BE SIGNED by the voter</u>. Please use black or blue ink <u>ONLY</u> to mark your ballot. Additionally, on the voter label if there is an "ID" Symbol or "ID Required", be sure to enclose a copy of your ID with your ballot. If ID is required and NOT provided your voted ballot will not count.

<u>ALL VOTED OFFICIAL BALLOTS CAN BE RETURNED:</u> To the Washington County Clerk & Recorder, P.O. Box L, Akron, Colorado 80720 via mail (with proper affixed postage) or in person at the Clerk & Recorder's Office. Office hours are M-F 8 a.m. to 4:30 p.m.; Saturday, June 22nd, 2024, 8 a.m. to 12 p.m. and Election Day 7 a.m. to 7 p.m. on Tuesday, the 25th day of June 2024. <u>All voted ballots must be received by the Clerk and Recorder by 7:00 p.m., Tuesday, June 25th, 2024. POSTMARKS DO NOT COUNT!</u>

24-HOUR DRIVE-UP DROP BOX LOCATION: Washington County Courthouse 150 Ash Ave, Akron, Colorado 80720, located in the northeast corner of the Courthouse in the alley between the Courthouse and the Courthouse Annex.

<u>Election Services provided at Washington County Clerk & Recorder's Office Voter Service and Polling Center Location:</u> To registering to vote; updating voter information; replacement ballots; return of mail-in ballots; cast a ballot either by paper or electronic voting machine; cast a provisional ballot.

<u>UPDATES TO VOTER REGISTRATION</u>: To check or change your voter registration, <u>visit www.govotecolorado.gov</u> or contact the Washington County Clerk and Recorder's Office at 970-345-6565. Note that Colorado is a same-day-registration state, which means voters can register or update their voter registration all the way through Election Day until 7 p.m.

TO MAIL A BALLOT TO THE VOTER: The deadline for the Clerk and Recorder to receive a mail-in ballot application if voter hasn't received one is Monday June 17th, 2024. Last day for an individual to submit a voter registration application through the online voter registration system, mail, voter registration agency, or local driver's license examination facility and receive a ballot via mail is Monday June 17th, 2024.

REPLACMENT BALLOTS: If you spoil, deface, or lose your ballot, you may obtain a replacement ballot by contacting the Clerk and Recorder's Office at 150 Ash Ave, Akron, Colorado 80720 or by calling 970-345-6565.
