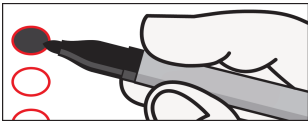




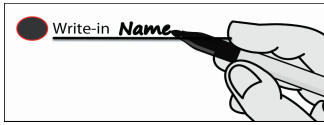

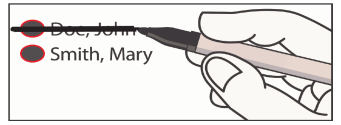

To vote for a named candidate, completely fill in the oval to the left of your choice. Use blue or black ink.



To vote for an eligible write-in candidate, completely fill in the oval to the left of the write-in line, and print the name of the candidate on the line. If a race does not contain a write-in line, you cannot vote for a write-in candidate.



To make a correction in a race with more than one candidate, draw a bold line through the oval and candidate name marked by mistake, then fill in the oval next to the correct name. If you voted for the only candidate in a race and want to withdraw that vote, you must request a replacement ballot.

**WARNING:** Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. She put her own beliefs first and did not represent the people that voted her in.</p> <p><b>Board Member Hutchison's Statement:</b></p> <p>I would like to address my recall as director of District A in the Buffalo RE-4J School District. I returned to the board because I believed the Covid mandates to be government overreach and a violation of the rights of children. Parents should make the medical decisions for their children and not the government. Children were never the drivers of Covid infections and have a 99.997% cure rate for those under the age of 19yo. I was there to do my best to advocate for them since they had no voice.</p> <p>I never intended on returning to the board to immediately be faced with replacing a long term superintendent that had moved out of state without notifying the board prior to his relocation. The board consulted with attorneys in executive session to decide the best course moving forward for the school. To believe that one board member out of five had the authority to fire a superintendent on their own is wrong. I did attempt to ask what I felt was an important question regarding the Covid mandates in the superintendent interview process but was stopped by a Case member as well as the school attorney.</p> <p>I believe the personal beliefs that Mrs. Hutt is referring to is that Jesus Christ is my Lord and Savior and I do my best to not only listen to him but seek guidance from him in all areas of my life.</p> <p>This recall is going to cost the district approximately \$50,000 dollars, money which could be used for the children in our district.
